Outstanding State Employee Award



In 1957, SCSEA created the Outstanding State Employee (OSE) Award. Selection of the recipient is based on the nominee's exemplary service to the SC State Employees Association, to the state, both as an employee and as a citizen, to the community and exhibits outstanding personal traits. The statewide esteem of this award and personal prestige of its recipients are the result of the caliber of past OSE Award winners. Beginning in 1966, two OSE Awards have been presented yearly, one to an outstanding male employee, and one to an outstanding female employee.

Nominations for the OSE Award must be made through a member of the SCSEA Board of Directors, or through a SCSEA Chapter, and the nominee must be a member of the S. C. State Employees Association.

The policy governing the Outstanding State Employee Award is as follows:

- 1) That award is given to two members of the S. C. State Employees Association who have rendered unselfish, distinguished, and outstanding service to the SCSEA and to their community during the period of their service as state employees. This award will be known as the Outstanding State Employee Award.***
- 2) That this outstanding service award be limited to two awards annually, one to a male and one to a female and presented to the recipients at the SCSEA Annual Meeting.***
- 3) That nominations be made and signed by a member of the SCSEA.***
- 4) That nominations be submitted on a designated form, outlining qualifications of the candidate.***
- 5) That all nominations be submitted by May 1, 2017 and submitted to:***

- 6) That selections for the OSE Award be made by a confidential committee appointed by the President of SCSEA.***
- 7) That final selection is kept confidential and prior to the Annual Meeting, the Association's President will announce through news media the names of the recipients. Presentation of the awards will be made at the SCSEA Annual Meeting.***
- 8) That recipients receive the appropriate awards for this recognition.***
