Outstanding State Retiree Award



Following their retirement, many former South Carolina state employees continue to render outstanding service to SCSEA, the state, and their communities. In order to recognize their continuing contribution, SCSEA has developed the Outstanding State Retiree Award to honor these dedicated South Carolina state retirees.

Selection of the OSR recipient is based on the nominee's exemplary service to the S. C. State Employees Association and their efforts on behalf of retirees, to the state and their community. One OSR Award is presented annually at the Association's Annual Meeting.

Nominations for the OSE Award must be made through a member of the SCSEA Board of Directors, or through a SCSEA Chapter, and the nominee must be a member of the S. C. State Employees Association.

The policy governing the Outstanding State Employee Award is as follows:

1) That award is given to a retired member of the S. C. State Employees Association who has rendered unselfish, distinguished, and outstanding service to the SCSEA and to their community during the period of their retirement. This award will be known as the Outstanding State Retiree Award.

2) That this outstanding service award be limited to one award annually and presented to the recipient at the SCSEA Annual Meeting.

3) That nominations be made and signed by a member of the SCSEA.

4) That nominations be submitted on a designated form, outlining qualifications of the candidate.

5) That all nominations be submitted by May 1, 2017 and submitted to:

6) That selections for the OSE Award be made by a confidential committee appointed by the President of SCSEA.

7) That final selection is kept confidential and prior to the Annual Meeting, the Association's President will announce through news media the names of the recipients. Presentation of the awards will be made at the SCSEA Annual Meeting.

8) That recipients receive the appropriate awards for this recognition.
