Employment Issues/Legal Representation

Members of SCSEA may call our office to discuss employment related problems. In addition, SCSEA has partnered with the Pyatt Law Firm, LLC to provide additional assistance to SCSEA members. You may call them directly in Columbia at 803-750-5929 or their Newberry office at (803) 276-1118.

Our partnership entitles each eligible member to two (2) free consultation sessions annually of up to 30 minutes each on employment related problems. Where a consultation leads to follow-up legal services, the attorney's standard and customary rates will be discounted 30%.

Members may also receive a discounted rate of 30% on contracted legal services regarding the following areas: 1) wills and estates, 2) family law, 3) consumer protection, 4) personal injuries, 5) traffic violations, and other matters. ***You must mention The SCSEA Attorney Referral Program when you call to make an appointment.***

Telephone Calls: Feel free to call with any questions you may have during office hours.

Remember, we handle legal matters for a living. Do not hesitate to ask any questions. Our staff is happy to help with coordination of your case. However, an attorney is the only one who may give legal advice.

Costs & Fees: Generally there is a \$100.00 consultation fee for the first visit in matters other than Personal Injury and Worker's Comp. If the Pyatt Law Firm is retained, this amount will be credited against any retainer. All fees, i.e., retainer, hourly rate and costs will be discussed if you decide to hire the Pyatt Law Firm. [Remember, SCSEA members are exempted from the consultation fee regarding employment related matters for two (2) sessions annually.]

Personal Injury and Worker's Compensation:

The fee ranges from 33 1/3 percent to 50 percent. If there is no recovery, there is no fee.

Costs:

Every case has costs involved. Costs are the responsibility of the client even though they may be advanced by the Pyatt Law Firm. These may be different in each case. Some of the costs may include a filing fee, service of process fee, deposition costs, expert witness fees, long distance telephone calls, copying and postage. In other types of cases, there may be costs for medical reports, records, accident reports as well as those set forth above.
